I Leveled off and went to the paint shop
I sprayed the underbody of Oldsmobiles
as they went down the line. It was
god Awful working conditions. It was the
worst I ever had. It was so boring
I went to my Doctor and complained
about headaches from fumes. Was put on
the Wet Deck, just as bad of a job but
I could talk to people. used a side wheel.

Environment? The 70's it wasn't highly automated
back then people did the sealer wands, wet sand,
sprayed paint. The place just stunk.

Summer/winter) The ovens and the summer made
the place really smell. The wetdeck wasn't bad
cause we could play with the water and
it was a bit cooler.

The beginning of your time in F.B.? Back then
I was amazed, installing vinyl tops was a
great job I thought. Jim Shock was the
Committee man. My brothers would complain about
the job. And they would take care of the job.
Nobody wanted a new kid fighting a job it
didn't look good. No women on day shift
but there were on night shift. The people
in the shop were wonderful.

The people were the greatest. Any ~~beer~~ imitation? No, I knew I belonged cause the older guys would invite me out for a beer, They would say "Come on kid!"

Taught me the job Ray Fish, Don Rathburn still bump into them at farm Auctions. 7 people were hired in the same day AS I WAS. I WAS sitting in the General formans office.

I went International 7 years ago. 76-99 I was on the line. It would amaze me that Uncle Joe had 28 years and bolting in seat belt bolts. I do every 6th job and he did every car. He just came to work and kept his mouth shut. His supervisor would reward him occasionally and give him an easy job. When Uncle Joe retired bolting seat belts. when you see him today he is all bent over. I know why he walks that way. I self medicated and got threw it.

Transfers were the way to get off a bad job.

Name Changes? It will always be Fisher Body.

~~There~~ was a pride in Fisher Body. The Union was stronger. I ~~had~~ had the pride. we lost that Identity, Its sad.

Being young on nights? Started a family later in life. Back then we didn't have the competition with foreign cars. If you wanted the day off you put your name on the Supervisors List.

PP H day were like Christmas better
then your Check.

30 - 35 people in an area 5 or 6 extra people

We Liked to gamble / Andy Graham & Michelle Penfield
we would cook in the ovens. Holiday we would
do hams and turkeys They knew how long it
would take

We would pitch nickles against the wall

elevate to Quarters.

First experience with Trades was when I
was District Committee man. We got the Wastewater
treatment and power house. I would get A call
And they would complain about their pay check and
I was almost insulted. They had a nice environment
to work in.

Tag vs. Mass Relief

we had Tag relief. A relief man was a good job. Management wanted Mass Relief. Mid term they wanted to wipe out the relief men. I told Zubkus that we were walking. Zubkus said no your not. Mine was a bluff, I didn't know. When the final push came down The Shop Committee was divided. CAI Rapson didn't want the Shop Committee divided. 9:30 AM CAI had to leave told us to talk about it. Lots of fighting ~~and~~ And yelling. final vote was 5-2 in favor of mass relief. CAI came back and CAI called yockish and CAI came back with a 602 t-shirt on and I knew we were walking. The strike lasted 4 days we returned to work on Tuesday. It went to the employees for a vote. I put out a letter and told people to not unionize the plant. Membership voted to keep Tag Relief. Then Bloody April - Mgmt said no new product till we went to MASS Relief.

GOT REDUCED OUT OF TRIM AND LEVELED OFF INTO THE PAINT SHOP. THOUGHT ABOUT QUITTING BECAUSE THE WORK CONDITIONS WERE SO. BAD. HAD TO WEAR A PAINT SUIT IN VERY BAD CONDITIONS WHERE YOU WERE STUCK IN A BOOTH WEARING A HOOD THAT FED AIR TO you. You could NOT TALK OR ANYTHING in THERE.
