REGIONAL UPDATES

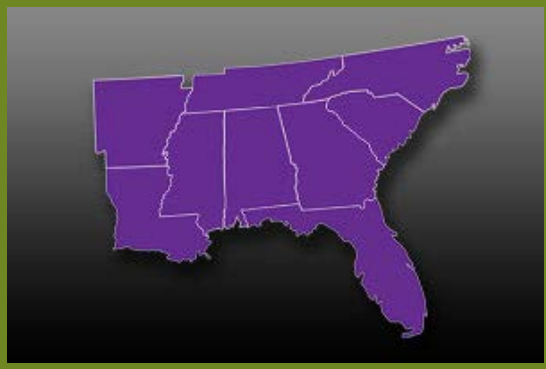

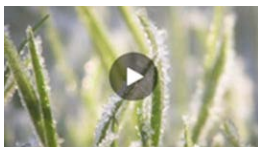
USGA Green Section Internship Program - Now Accepting Applications
