On the wheat stand, Theo. Wood of the Chicago savings bank made the emphatic statement that in his opinion that institution was solvent and that banking commissionaries closed its doors.

In the case of O. J. Torrey and others, of Manchester, vs. the Toledo Portland Cement Company, better known as the Manchester Portland Cement Co., the plaintiffs Torrey and others have filed with the county clerk their claim of appeal to the Michigan supreme court, from the decree given by Judge Kinnear on December 30, 1908. By this decree, the bill of complaint was dismissed as to William Watts and C. M. Cooley and as to T. Van Valkenburg was ordered to account for only \$750. Complainants contend that the bill of complaint should not have been dismissed as to Watts and Cooley and Van Valkenburg should have been compelled to account at \$9,000.

The board of supervisors finally decided to give the people a chance to vote on local option next spring. Before we are taking chances on the result, the report of the committee on the question is as follows: "We find that upon examination the petitions asking for the submission of the question of local option at the coming spring election have the number of signatures required under the statute. In regard to pointing the petition to comply with the law, we find that the township of Bridgewater has several petitions separately and in different parts of the town, not having the names of all petitioners on one sheet, which numbered signatures signed. Allowing these to be cut out, the local option petitions would still have the required number. With regard to the so-called illegal election on said petition, we find that if they were cut out of the local option petitions there would still be sufficient number of signatures for submission. Relative to the withdrawal of cards we find that it is beyond our jurisdiction to decide relative to the same. A summary of what we have found is as follows: Petitions asking for submission of local option according to our census would require one third of the highest vote received by state officers voted for at the last election which would be 3,700. The said petitions there were the face of the same 4,000 signatures, which is 402 more than the law requires for submission, the number of alleged illegal voters is claimed to be 392, the number of withdrawal by cards are 495."
