## BOYS AND GIRLS HELP IN WAR

Organizations Being Perfected That Will Teach Youth to Help in Food Situation.

A boys' and girls' Liberty Food Club is being organized by the U. S. Department of Agriculture and the State Agricultural Colleges, composed of all club members in the 33 northern and western states. In order to become a member of this club each boy and girl enrolled in club work must sign a card pledging himself or herself, through food production and food conservation, to help win the war and world peace. By this pledge each member promises to endeavor to the best of his or her ability to follow instructions, attend meetings of the club, make an exhibit, keep accurate records, and make a complete report of his or her activities and achievements. Each member is then furnished with a handsome certificate signed by the state club leader, and upon successfully completing the work of the club for the year is given a diploma of achievement.

Michigan potato growers can lessen the drain on their pocketbooks and more effectively control the diseases which attack their crop if they will make up their own bordeaux mixture. No patent bordeaux, ready-mixed article which the farmer can prepare for himself in a jiffy and at less expense than the commercial kind. Instructions for making up the home-made mixture, with methods for most effectively applying it have been published in bulletin form. The bulletin can be obtained by addressing a card to the experiment station of M. A. C.

Close Watch Should Be Kept That Few Cases Do Not Result in Dangerous Epidemic.

A number of cases of hog cholera in Washtenaw county have come to the attention of the county agent. Any farmer having sick hogs should at once be suspicious of having this disease in his herd. Often the dis- ease appears without any apparent reason.

In case of sickness in the herd it should be reported to the county agent immediately, so that prompt action can be taken. His services are free to the farmers. If it proves to be cholera it is necessary to ac- tively in order to save the rest of the herd.

## IRISH HILLS CALL AUTOISTS

Exceptionally Scenic Drive More Easily Accessible Than in Former Years.

When at Wampler lake a few days ago, a company who were out for an auto drive inquired of us the way to the Irish Hills. They said they had often heard of what a ro- mantic drive it is, how beautiful the scenery of the surrounding country is from the top of the hills, and they were anxious to drive over them.

Since a better road has been made around the east end of Wampler lake at the foot of Cedar Hill, it is safe to drive that way from The Farm Hotel. We advise all drivers to stop in safe positions in slightly places, dismount and find a place where they can "drink in" the full beauty of the sur- roundings. There are innumerable lakes to be seen nestled among the hills, some almost hidden by the luxuriant forest trees, but one can readily count a score from one of the numerous hill-tops.

At the "Siam" schoolhouse, if you turn to the right and drive up the hill you will pass several beautiful lakes and some splendid farm homes before reaching the pike again, west of Wampler. To go to Brooklyn, you should turn to the left; to go to Wampler, to the right.

If you keep straight on instead of turning at the Siam schoolhouse, you will soon reach Cambridge Junction, where the Monroe turnpike joins the Chicago turnpike. At this place is a large brick hotel which in pioneer days was known far and wide. Keep straight on west for Jonesville, and Chicago; turn to the right for Brook- lyn and Jackson.

The roads are very good over the hills, but of course, being winding and somewhat steep, the driver must use caution.

These editors claim that Carranza is fast bringing order out of chaos, that there will never again be revolutions there, that prospects for peaceful industrial conditions there are even better than existed under Porfirio Diaz. We hope so.
