The public debt decreased \$14.233,324 during March. Deducting the cash in the treasury, the total indebtedness is \$1,409,262,809. Before the Springer committee at Wash-ington, George Bliss tostified that his charge as counsel in the star-route cases was \$52, 532, of which \$43,443 was for expenses.

The postmaster general has directed, according to law, a readjustment of salaries of postmasters at 2,405 offices, the same to take effect July 1, 1885.

The house committee on post-roads adopted a resolution declaring it inexpedient for the government either to construct a postal telegraph or purchase any existing line.

With the additions made by the sense: committee on appropriations, the naval bill calls for \$20.786,676. This includes \$2,000,-000 for continuing work on the double-tur-reted monitors, and \$2,500,000 for additional

John Jay Knox, comptroller of the currency, has placed his resignation in the hands of President Arthur, and will soon take control of a New York banking house, at a salary triple that received from the

A report, just made to congress by Statistician Dodge, of the agricultural department, shows that the stock of wheat on hand is 119,000,000 bushels of which 4,500,000 bushels are in lilinois, 9,500,000 bushels in lowa, 7,500,000 bushels in Wisconsin, and 13,500,000 bushels in Wisconsin, and 13,500,000 hushels in Minnesots, The postal service was last year self-supporting only in fifteen states and two territories—the latter being Alaska and Dakota. Ohio showed a deficit of \$430,168, while Illi-

nois paid a profit of \$852,519. Not a dollar

of postal revenue was ever received from a state south of Mason & Dixon's line. A recent report by a special agent of the land-office, that a tract of 720,000 acres of public land in Colorado had been fenced by parties without the slightest authority, has attracted the attention of congress. Commissioner McFarland recommends that the fencing of public territory be made a penal

For the past nine months the receipts of the government were \$92,204,695 in excess of the expenditures. When compared with the preceding period it appears that the custions payments have decreased \$15,500,000 and the internal revenue receipts nearly \$21,000,000. But the expenditures also show a falling off of over \$18,500,000.

During the past ten years the government has expended nearly \$70,000,000 in caring for the Indians. The total number of Indians. ans attached to agencies is only 240,000, and these 60,000 in Indian Territor Wisconsin, and 5,000 in New York are supposed to be at least partially self-support-

In the last twenty years the government has pald for interest on the public debt the enormous sum of \$2,098,000,000, a sum which would defray all the expenses of the government, excepting interest on the public debt, for nearly nine years to come at the present rate of expenditure; and for nearly thirty-five years if expenses could be limited to what they were in 1860.



Yet, an elector who, four days previously, had removed from the first into the fourth ward, was denied the privilege of voting in the first ward on Monday.

Section 15 contains this provision: 'No ballot shall contain a greater number of names of persons designated for any office than there are persons to be chosen at the election to fill such office." One ballot taken out of the ballot box in the first ward contained the name of Edwin A. Gould for Alderman, also the name of Hiram L. Lewis for Alderman. It is plain enough that the ballot should not have been counted for either name, but we are fold, Ald. Lewis declared it must be counted for himself and it was so counted because his name was not erased or obliterated. Now Ald. Lewis' returns show that he has a majority of 2. 





year without loss of page. During the first eight months of the present fiscal year the internal revenue receipts were \$75,000,320, a decrease of \$14,451,350 as compared with the corresponding period of 1883. The aggregate receipts for February were \$2,040,862 less than in February, 1885.

The house committee on labor has unanimously agreed to report a bill forbidding the leasing of the labor convicts confined in any prison for violating the laws of the United States, under penalty of fine and unprisonment.

The committee on banking and currency is considering the propriety of so amending the national bank laws that examinations may be made more frequently and directors be held to an accountability for irregularities. This is the outgrowth of the failure of the Pacific National bank of Boston.

Senator Vance, in a minority report on the exclusion of American pork from Ger-many, contends that hog product may be barred out by foreign nations if deemed unwholesome, and that such course is manly when contrasted with the American method of imposing prohibitory import duties to effect the same purpose.

President Arthur on Wednesday sent to congress a special message advising appropriations toward commencing the construction of three steel crusers and four gunboats, to cost \$4,383,000. The executive thinks it imprudent to delay work on these vessels for one year. He also urges the appropriation of \$2,000,000 for finishing four doubleturreted monitors.

Minister Sargent's transfer from Berlin to St. Petersburg, for which the preliminaries have been completed, will take the country by surprise. The views of the administration are clearly stated by Secretary Frelinghysen, who cabled Mr. Sargent that his course in the Lasker matter was approved, and that the change was prompted only by regard for the minister's personal feelings.

The house committee on invalid pensions has decided to report a substitute for the Robinson bill, which will give a pension to any ex-union soldier who was confined in a confederate prison and is now found by the board of surgeons to be suffering from any diasbility. The measure also provides for pensioning the widow of any confederate prisoner of war who died from the effects of confinement.

Minister Sargent sent to Secretary Fre-linghuysen a cablegram expressing his grati-tude for substantial indorsement but de-clining to accept a transfer to St. Peters-burg. In reply to a second communication from Washington, Mr. Sargent stated that ill health caused him to take a leave of ab-sence, after which he would formally an-nounce to the German government his resignation.

The river and harbor committee has nearly completed its consideration of the proposed river and harbor bill. It is understood that the aggregate of the bill will not exceed \$11,000,000. The principal items will be appropriations for the Mississippi, Missouri, and Ohio rivers, and the great harbors on the Atlantic, Pacific, lake, and gulf coasts. To the Mississippi and tributaries about \$5,000,000 will probably be appropriated. The committee has not yet decided what part of that amount shall be expended upon the Mississippi itself. Members of the house are being invited before the committee to make such statements as they see proper concerning the improvethey see proper concerning the improve-ments of their respective districts and states. The bill will be reported to the house not later than April 20.

A TELEGRAPH BILL The bill introduced by Representative Money for the purpose of securing correspondence by telegraph at cheaper rates Money for the purpose of securing correspondence by telegraph at cheaper rates authorizes and directs the postmaster general to enter into a contract in behalf of the United States with the postal telegraph and cable company. Within five years from the date of the contract the company shall be prepared to do business in all sities in the Atlantic division having postoffice delivery east of the Mississippi and Missouri rivers and south of Omaha and Minneapolis. Within seven years the business shall be extended to the Pacific coast, and shall be known as the Pacific division. The rates proposed are to each for twenty words and 10 cents for each additional ten words, and 15 cents each for a night message of twenty words in the Atlantic division. Pacific division rates from the Atlantic division shall be 50 cents for each additional ten words, and 25 cents for night messages of twenty words, and 25 cents for night messages of twenty words. Newspaper rates shall be three-fourths of 1 cent for day service and 1 cent for points between the two divisions the rate is increased 4 cent in each instance. Between New York, Philadelphia, Baltimore, and Washington, and between all other points embracing only short distances, rates shall be 1 cent per word at night. The bill provides that stamps shall be issued for conducting the business.

Be it enacted, etc., That any soldier of the late war who has been honorably discharged from the army or navy, and who served in the army or navy for any period not less than fourteen days or more than one year, shall be entitled to eighty acres of public land, and if he served in the army or navy over one year and less than two years. navy over one year and less than two years he shall be entitled to one hundred and twenty acres of public land, and if he served in the army or navy over two years he shall be entitled to one hundred and sixty acres of public land

acrès of public land.

Sec. 2. That such soldier may select the tract of land granted him by the first section of this act from any unoccupied public land, and file his discharge with record evidence of the length of service in the armyor navy, in the district land office wherein such selected land is situated, and pay into said land-office the fees now provided by law for making entries of public lands; and thereupon the register of the land-office shall issue to him a certificate describing the selected land, which shall entitle him to a patent from the United States for the same; and then such register shall cancel such discharge and keep a public record of the same, fully describing it therein, with the name of the person receiving such certificate; and the person receiving such certificate; and from the date of such certificate the land therein described shall not be sold or liable




