The North American Review concludes its seventieth year with its June number. It never had so large a circulation, nor greater influence, nor a more brilliant staff of contributors. This number discusses seven topics of vital public interest by no less than fourteen eminent writers, not including the short contributions in "Comments." "Shall Silver be Demonetized?" is answered pro and con, by three distinguished economists, Sumner, Laughlin and Walker, representing Yale and Harvard Colleges, and the Massachusetts Institute of Technology. "The Fardness of Justice" is discussed by Judge W. L. Learned, and "Prohibition in Politics," by Gail Hamilton; "The Swearing Habit" by E. P. Whipple, and "French Spoilation Claims," by Edward Everett. The policy of the Roman Catholic hierarchy toward our Public Schools is assailed in a learned essay by a new polemic, Mr. M. C. O'Byrne, of North Carolina, and defended by Bishop Keane, of Virginia, with equal erudition. It is a most interesting double presentation of an impending issue. "How Shall Women Dress?" is answered by Charles Dudley Warner, Elizabeth Stuart Phelps, Dr. W. A. Hammond, Dr. Kate J. Jackson, and Mrs. E. M. King, the English leader of the dress reform movement.

A Remarkable Woman—W. W. Cole's Mother Travels With the Show.

A rumor has sometimes reached the public that Mrs. M. A. Cole, mother of the famous showman, is really the controlling spirit of the vast business which bears his name, and that all the success he has achieved is due to her shrewdness and executive ability. While this is not true, there is still much that can be said in praise of this remarkable woman who, at the advanced age of 68 years, cheerfully endures the hardships of a showman's life and does a man's work every day in the week.

Mrs. Cole was, many years ago, a circus rider in Great Britain, and her husband, long since deceased, was a contortionist in the same company. She comes of the celebrated Cook family, being related to the Cook Bros., who today have three large shows running in England. Mrs. Cole has traveled with her son's show ever since he started out in 1859. She works every afternoon and evening in the Treasurer's wagon counting tickets, checking up against the Treasurer, etc. Those of the company who happen to make her acquaintance say that she is kindly disposed and treats them well. Mr. W. W. Cole himself is only 38 years old.

MINISTER LOTHROP EXPLAINS.

He Promptly Clears Himself of the Malicious Attack.

On the appearance in the N. Y. Tribune of the opinion of the N. Y. Court of Appeals, raked up from the records of twenty years ago, to bring discredit upon President Cleveland's appointment and gratify some personal envy and malice, Mr. Lothrop promptly met the case with the following explicit explanation given to Detroit papers:

I am informed that the New York Tribune has to-day published the opinion of Judge Potter in the case of Michigan vs. Phoenix Bank, in the New York court of appeals, as an impeachment of my personal character.

In my present position my character is the fair subject of public scrutiny. But this opinion, perhaps unintentionally, does me cruel wrong, which I am sure the author, if he knew me, would be the first to redress. The wrong consists in this, that, by implication at least, I am involved in certain contentments made by the bank, of which I never had the slightest knowledge.

I will as briefly as possible state the case as presented to me.

In 1838 the Phoenix bank advanced to John Norton, fiscal agent of Michigan for the use of the state, about \$16,500 in two drafts, one on the Farmers' and Mechanics' bank of Michigan and one on the River Raisin bank. The state fell into great financial embarrassment and the money was not repaid. Question was also raised whether Norton had any authority to make the loan for the state, and whether the state had the benefit of it.

The Phoenix bank put the claim into the hands of Mr. Chas. H. Stewart, an attorney, of Detroit, for collection, who about 1840 to 1848, when he left the state and afterwards returned the papers to the Phoenix bank. The action of Mr. Stewart while he had charge of the claim became, as will be seen, of the utmost importance.

In 1853 Mr. Tilton of the then eminent firm of Spofford & Tilton, President of the Phoenix bank, came to Detroit and put the claim into the hands of Lothrop & Duffield, then comparatively young lawyers, for collection against the state. This was the first that I had ever heard of the claim. He told me explicitly that not one cent had ever been paid. Among the papers was a deed of the State bank to Stewart, made in 1840, of a quantity of wild land in Saginaw county, "in trust for the Phoenix bank of the city of New York, or for the Auditor General of the state of Michigan, whichever shall assume the debt hereby settled by the party of the first part," and a subsequent deed by Stewart of these lands to the bank.

Mr. Tilton told me that Mr. Stewart sent the bank three deeds in a package with other papers in the case. But he told me that his bank wholly refused to accept the deeds, and that their claim was against the state and not against any bank.

Under these instructions I prepared the case for presentation to the Board of State Auditors, and in May, 1854, after notice to the Attorney General, I presented the case to the full Board in public session and argued it earnestly both orally and in writing. I argued it in the utmost good faith, fully believing it to be an equitable claim. I stated truthfully, so far as I then knew, not only the grounds on which I rested the claim but also all the objections I had ever heard against the claim. With this argument my agency in the case wholly ceased.

The Board had the case under advisement over six months, when they awarded the bank its entire claim, being about \$35,000.

Soon afterwards it appeared that there were facts which had not been disclosed to the Board. It appeared that in August, 1840, Mr. Stewart, it is said, under the authority of a letter from the Phoenix bank, had made a full settlement with River Raisin bank of that part of the claim.

I never heard a whisper of this until long after the award; and though I do not know, I have always supposed that Mr. Tilton was equally ignorant, as he was not President of the bank in 1840. And I am not aware that it is claimed that Mr. Tilton had any knowledge of Stewart's dealing with the state other than what I have given above.

Upon the ground of this concealment by the bank of the settlement made by Mr. Stewart with the River Raisin bank, of which, I repeat, I never had the slightest knowledge, the court of appeals held that the state could recover back so much of the claim as had been settled with the River Raisin bank, but could not recover back the residue, the state having had the benefit of it. In this concealment I had no part nor lot, except as I was the Attorney of the bank and did not disclose what I neither knew nor suspected.

I should add that I had no interest in this claim. I dealt with it as I have always dealt with professional matters, with seal and fidelity, but careful, as far as I knew, to be right. For the recovery of this large sum Lothrop & Duffield charged and received only \$1,000; and for this sum I was a conspirator!

Over fifty-five years ago, when these facts were first disclosed, this whole matter was thoroughly discussed, examined and settled here in Michigan. It was then buried out of sight. It is now exhumed, not at heart, but abroad, where I am not well known. It certainly wounds me; not for myself for that is settled; but it is designed to embarrass those who are the trust of a high appointment, have reposed confidence in me, and I feel that I have been made a laughing stock. 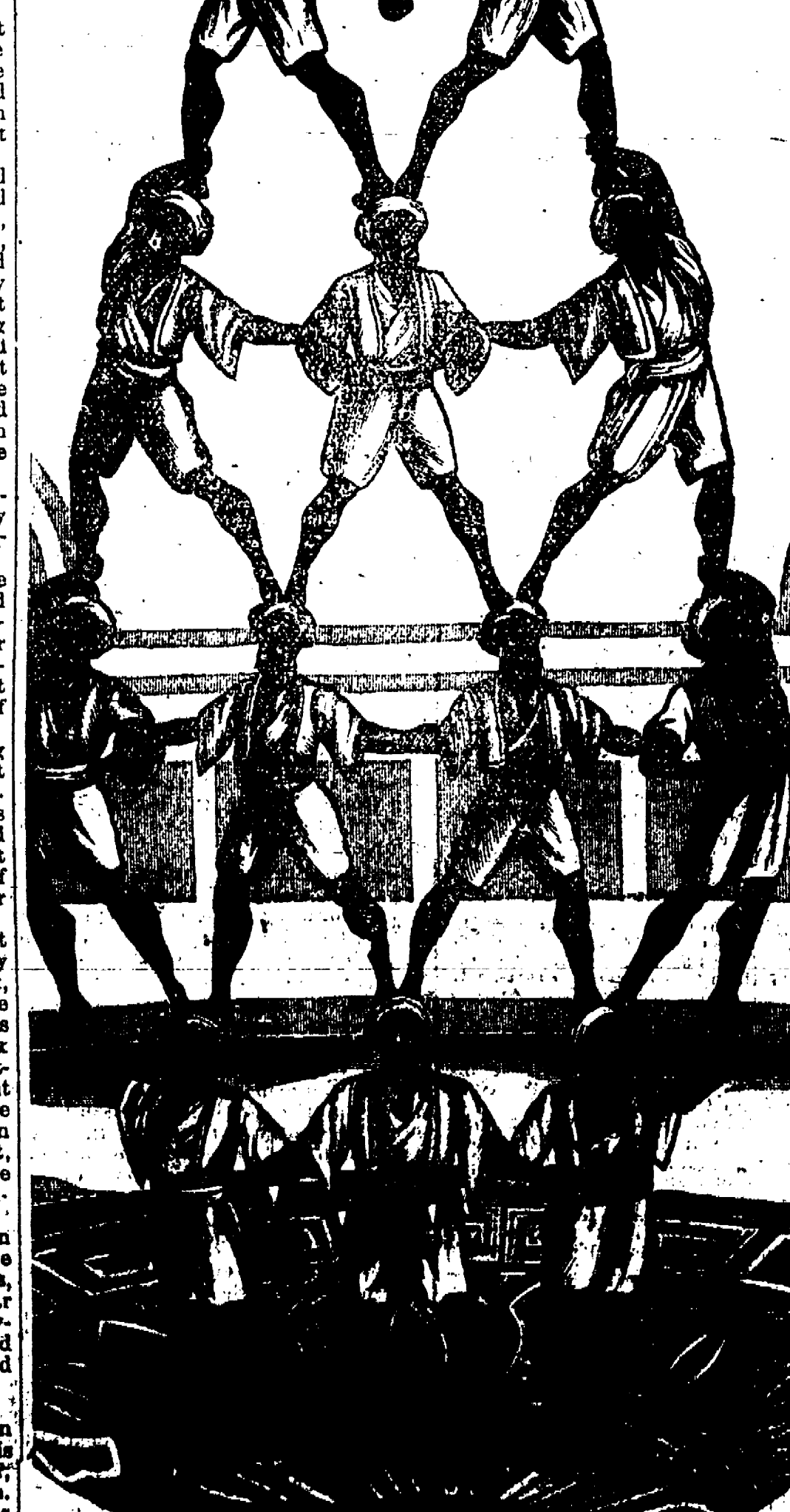

Visit to a Pueblo in New Mexico.

President Cleveland dispatches a good batch of appointments daily.

Postmaster Gage, of East Saginaw, is removed on charge of dishonesty, and Martin V. Meredith, on recommendation of Congressman Tarnsey, is appointed in his place.

U. S. Senator Palmer, of Detroit, gave an elegant dinner party at his residence last Friday evening in honor of U. S. Minister Lotthrop.

The principle that the party in power should hold the offices for the administration of the government, is having exemplification in the way the intention of Republican assistants to the Democratic heads of departments, works. It is found that Democratic officials cannot carry on investigation of suspected corporations of the late government while they have Republican clerks and assistants.

True to their party affiliation, these latter "peach" on what is going on, and suspected parties have a chance to thwart investigation. So, although the government at Washington may not favor the sweeping Jacksonian doctrine, "to the victors belong the spoils," it will doubtless be compelled to resort to the same in effect, as it is learning that in order to accomplish any thorough work of reformation, the subordinates must be in accord with the administration, and nothing short of a "clean sweep" will suffice.

THE LEGISLATURE.

Both houses of the Legislature adjourned Friday noon until Monday evening to allow members to go home and participate in Memorial Day exercises.

The Senate Committee to whom was referred the bill to detach a portion of Middlebury, in Shiawassee county, and attach it to the township of Ovid, in Clinton county, reported the bill back to the Senate without recommendation and asked to be discharged from the further consideration of the subject. On motion of Senator Pulver the bill was laid on the table. Later—Yesterday the bill was, on motion of Senator Pulver, indefinitely postponed, and that ought to be the end of it.

The bill to prevent the manufacture and sale of oleomargarine has passed the Senate, and been referred in the House to the Committee on Public Health, which committee, it is expected, will report the bill back today. An amendment to pay manufacturers for machinery rendered useless by the passage of the law, was adopted and afterwards rejected by the Senate. The provision for the appointment of a dairy commissioner was struck out of the bill. The bill passed the Senate by 18 to 4—Senator Pulver voted against it.

The bill annexing Springwells and other territory to Detroit has become a law.

A joint resolution for submitting to the people an amendment to the Constitution, fixing the pay of members of the Legislature at \$1,000 for a regular session, with the usual mileage, and \$100 for an extra session, has passed the House. Also one allowing the Legislature to fix the salary of Governor and other state officers.

The Tax bill passed the Senate by a vote of 26 to 2. Senator Pulver voted for it. The bill was then made the special order in the House for each afternoon until completed. It was expected to come up on third reading yesterday.

Later—The Tax bill passed the House yesterday.

The bill which passed the Senate to provide for equal representation of political parties on boards of election, was laid upon the table in the House.

The bill to light the Capitol with the incandescent electric light has been reported favorably by the Senate Committee.

The bill making ten hours a legal day's work, except on farms, has passed the Senate.

The Representative Apportionment bill will probably come up in both houses this week.

The Pharmacy bill has passed both houses. Also a bill to prevent the sale of immoral books.

The ever recurring bill to secure uniform text books in primary schools, was indefinitely postponed by the House.

The resolution requesting the Governor to call an extra session to perfect a general tax law was tabled in the House, Friday.

GENERAL NEWS.

Five Americans connected with the University of Tokio are to be decorated by the emperor with the order of the sun.

About two hundred representative delegates of Chicago participated in the dinner given to Senator Logan by the Union League club.

John Connelley, who shot himself at a saloon in New York, New Jersey, last Monday morning, after expressing regret for his course.

A respectable woman of California, who was married to a man who was killed by a train, has been awarded a divorce by a California court.

The wife of a three-story house owner in Chicago, who was killed by a train, has been awarded a divorce by a California court.

C. Williams and other Chicagoans are expected to move to organize

the United States Ballot-Box company, with a capital stock of \$500,000.

In the southern Presbyterian assembly, an amendment to the confession of faith designed to permit marriage with a deceased wife's sister failed of passage.

James N. Ray, confidential clerk in the New York banking house of Martin & Remy, has confessed the embezzlement of \$25,000, which he lost in Wall street.

Nearly six hundred indictments found against liquor-dealers at Wheeling, West Virginia, have been stolen from the office of the clerk of the circuit court.

The rail-mills at Pittsburg and Cincinnati have resolved to shut down next Saturday night rather than pay the wages demanded by the Amalgamated association.

Willie Prentiss, of Orange, Massachusetts, was ordered by his drunken father to shoot a cup which he held on his head, the result being the instant death of the patient.

The business quarter of Medford, Wisconsin, was nearly destroyed by fire Thursday, the loss being very heavy. Twelve buildings at Phoenix, Arizona, valued at \$75,000, were also burned.

The governor of Pennsylvania has approved of a bill to punish any person having oleomargarine in his possession after July 1. Wholesale dealers in Philadelphia are represented as highly indignant.

By the collapse of a brake on the Kanawha incline at Charleston, West Virginia, two carloads of miners were carried up the mountain at great speed. Three were killed and one fatally hurt by being run over.

Most of the indebtedness of the Perry brothers, once heavy lumbermen in Michigan, have been extinguished by the action of several Eastern banks in accepting certain real estate of the firm at \$100,000.

Nearly ten thousand persons assembled Wednesday at Cambridge, Ill., to witness the unveiling of a monument erected by Henry county in memory of those of her citizens who fell in the war for the Union.

Theodore Hunt, a well-known turfman of St. Louis, having lost the greater portion of \$100,000 left by his father, has been placed in St. Vincent's insane asylum. His mania was the purchase of patent rights.

At midnight, Saturday, 350 men rode into Corydon, Kentucky, and deposited in the postoffice letters to county officials demanding an investigation of the treasurer's books at once. The mob went quietly away.

W. J. Jocelyn, a carpenter at Grand Rapids, Michigan, undertook to hang himself because of the death of a horse. He was cut down while black in the face, and half an hour's labor was required to restore him.

The wheat crop of California, as estimated by the secretary of the State Agricultural society, will be less than half that of last year. The increased acreage in Oregon and Washington territory is 42 per cent.

The city clerk of Shenandoah, Iowa, reports four cases of small-pox and five of varioloid in the past three weeks, with one death. The schools and churches were closed, and an impartial quarantine has been enforced.

Frank O'Neil, of St. Louis, who was selected by the authorities to go to New Zealand for the murderer Maxwell, has accepted the managing editorship of the *Missouri Republican*. William Hyde is making a tour of Europe.

In a Philadelphia court Margaret Brooks was sentenced to four months' imprisonment for being a common scold. Her grown daughter, struck a lady witness in the face, and was given four months for contempt of court.

A young woman in St. Louis, giving the name of Flora E. Downs, claiming to be a newspaper writer from England, broke the show window of a jewelry store and took out some goods in order to secure shelter and food in prison.

The reformed presbytery of Philadelphia has been received into the Presbyterian church. The committee on foreign missions reported to the general assembly the receipt of \$999,869 for the year, and an existing debt of \$27,751.

The managers of the New Orleans exposition claim to have secured nearly all the funds required for its extension, but the refusal of the cabinet at Washington to permit the Government exhibits to remain is thought to have killed the scheme.

On a seat in a train which reached Dubuque Saturday evening was found a babe with a club foot, crying loudly. The unfortunate infant was tenderly cared for at a hotel near the depot. The woman who abandoned the child left the train at Galena, and efforts are being made to find her.

Whittaker, the colored cadet who claimed to have had his ears slit at West Point, appeared before the supreme court of South Carolina and was admitted as an attorney. For the past two years he has conducted at Charleston a military school for colored youth.

Judge Mann of Milwaukee, decided that an insurance company that city must pay \$250 and interest for a coat, skin cloak left by a lady in a dry-goods store, where it was burned. The defendant claimed that its policy only covered apparel contained in the plain-waist house.

Both houses of the Illinois legislature defeated resolutions for an adjournment on June 20. The Senate passed a bill for a State board for the inspection of food. The House adopted a joint resolution expressing sympathy with the people of France in the death of Victor Hugo.

Charles P. Barnes, of Woodlawn, Maryland, organist, liquor and food, killed his brother-in-law and his own son and wounded another member of the family. The sheriff's posse could scarcely prevent a lynching, and the murderer is likely to be taken from Milton jail and dispatched.

Miss Grace Lord, a literary celebrity in England, died at her home in London, at the age of 82. She was a member of the Society of Authors, and her works have been translated into many languages.

Marion Hargy, a female in the women's reformatory at Sydney, N. S. W., at Highgate, Illinois, was sentenced to be hanged as an assassin, after being convicted of the murder of a man.

A railway auditor at Chicago, whose body was yesterday found in the woods.

Madame Patti has made a contract for the coming winter including a tour of Europe, with the director of the Stadt theater at Hamburg.

The treaty which has been negotiated between England and China will permit the free disposal of opium throughout the latter empire.

Sixty pictures and one statuette in the royal academy in London have been mysteriously defaced, and the vile work still keeps up.

It is stated in London that the Sultan declines to occupy the Sudan with Turkish troops, and that this is the reason for holding the British guards at Alexandria.

The French minister of war has placed on duty in Paris several regiments from the provinces, on account of the threatening attitude of the communists, who intend to carry the flag at the funeral of Victor Hugo next Monday.

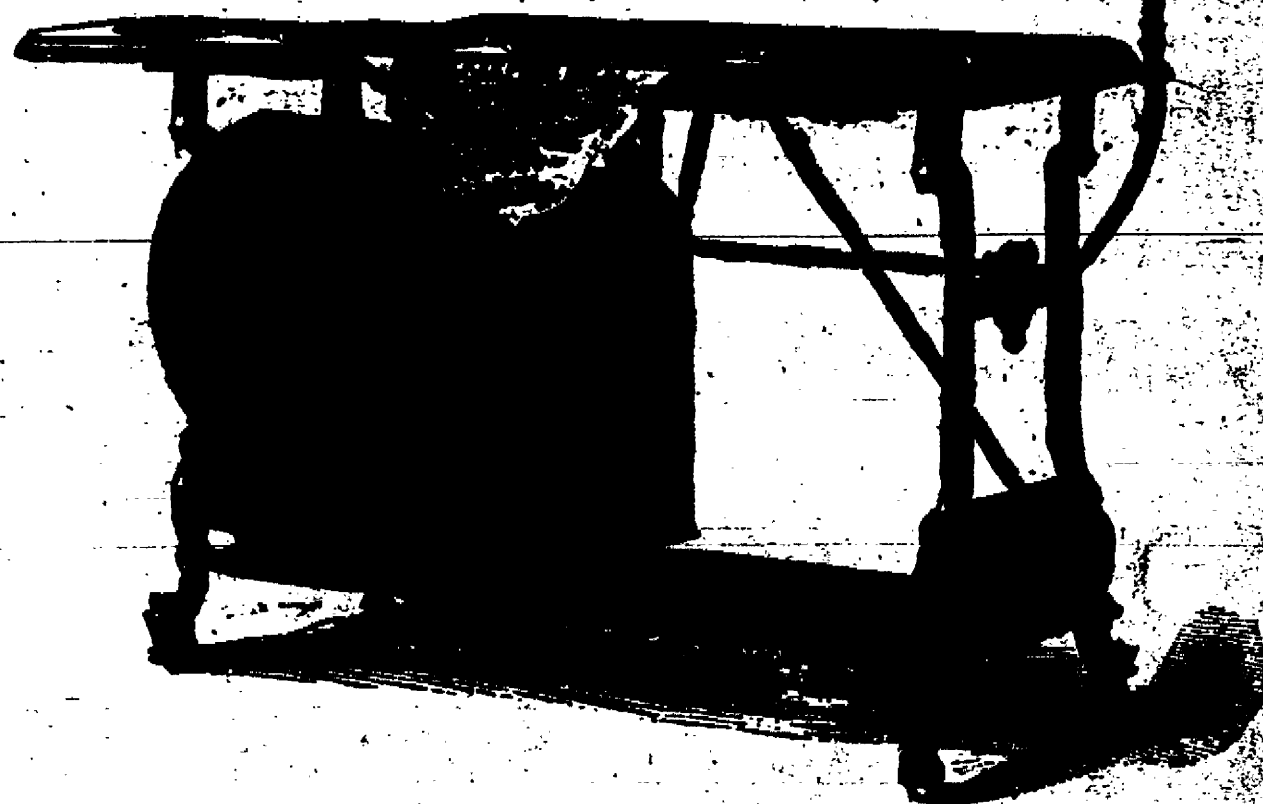

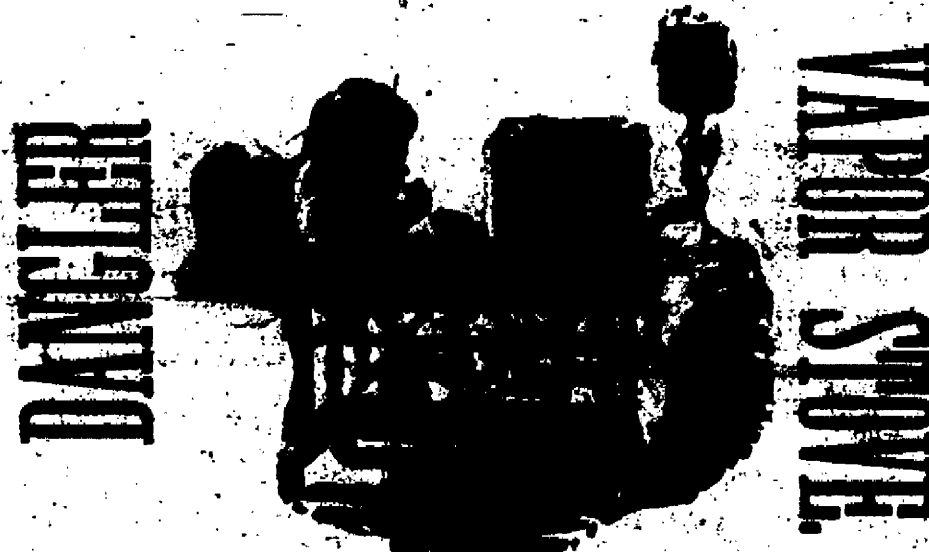
