# Miles to Cancel Dyrene and Fenthion

Miles, Inc. has petitioned EPA to cancel the use of fenthion on alfalfa, clover, pasture grasses, rice and ornamentals due to costs of environmental data for reregistration. The sole remaining use will likely be adult mosquito control in Florida only.

Miles, Inc. also has requested voluntary cancellation of all of its Dyrene fungicide products, which contain the active ingredient, anilazine, due to the cost of data for reregistration support. The following anilazine uses will be lost:

celery, green onion, strawberry, cucumber, lawns and turf, summer squash, gladiolus, potato, tomato.

EPA must yet publish this information in the Federal Register for a 90-day public comment period before the cancellation takes place. Miles has requested one year in which to sell its existing stocks of anilazine products.
