of Russ Forest land to Cass County Historical Society

Approval leasing 2. Michigan State University acquired 779 acres of the Russ Forest in two pieces, 579 acres in 1942 and an additional 200 acres in 1951. This land was a gift to the University from Mr. Fred Russ of Cass County. In 1974 Michigan State University leased a house on the Russ Forest property to the Cass County Historical Society. This lease was agreed to by the Board of Trustees so that the maintenance of this historical farmhouse would be assumed by the Historical Society.

> It is now recommended that a small portion (10 acres) of land at Russ Forest be leased to the Cass County Parks Commission to provide a public picnic and recreation area adjacent to the property leased to the Cass County Historical Society. There would be some linkage between the two leases since recreational users would have access to the historical house as an added feature of their recreational visits.

The administration of the College of Agriculture and Natural Resources is in agreement and history and rationale support the approval of the proposed lease agreement.

Approval agreement with Lodge 141, Fraternal Order of Police

3. A tentative agreement has been reached between Michigan State University and Lodge 141 of the Fraternal Order of Police, representing Public Safety Officers. The contract is retroactive to April 1, 1976 and terminates June 30, 1978.

Wage provisions provide for a \$350 payment for the period of April 1, 1976 to September 30, 1976. This amount will not be added to the Officer's base rate of pay. Effective October 1, 1976 the rate of compensation will be increased by 3.7%. Effective July 1, 1977 the rate will be increased by 5.35%. Other contractual changes include:

Health Insurance - An improvement in the health insurance program that is in line with that offered to the Clerical-Technical Association

Sick Leave - Improvement in the use of sick leave to provide usage for illness within the employee's immediate household

Grievance Procedure - The agreement improves the grievance procedure

Probationary Period - Was extended from nine to twelve months

Life Insurance - The Agreement contains language concerning the life insurance program which was implemented on July 1, 1976.

This agreement has already been ratified by the affected employees and Board of Trustees approval is requested.

RESOLVED that the agreement with Lodge 141, Fraternal Order of Police, is approved as recommended.

Unanimously approved. Motion by Trustee Huff, seconded by Trustee Radcliffe.

Approval agree- 4. ment with Local 274, Stagehands Union (IATSE and MPMO)

A tentative agreement has been reached between Michigan State University and Local 274, Stagehands Union, I.A.T.S.E. and M.P.M.O. The contract is retroactive to September 1, 1976 and terminates August 31, 1978.

The agreement provides for a \$.30 per hour increase during the period of September 1, 1976 through August 31, 1977. Effective September 1, 1977 through August 31, 1978 employees will receive an additional \$.30 per hour increase. The cost of compensation for the first year of the agreement equates to 4.76% and 4.54% the second year.

Ratification is expected from the affected employees and Board of Trustees approval is requested.

RESOLVED that the contract with Stagehands, Local 274 is approved as recommended.

Unanimously approved. Motion by Trustee Carrigan, seconded by Trustee Radcliffe.

5. In the interest of better utilizing the resources of their colleges, Dean Gwen Andrew, College of Social Science, and Dean Keith Goldhammer, College of Education, have requested that the Social Science Teaching Institute be discontinued.

This Institute was established in 1964 in an effort to move forward in the areas of research and instruction. The Institute has over the years been able to attract substantial outside funding and productivity has been high. However, the need for an identifiable institute has diminished to the point where its continuation at this time constitutes an unnecessary administrative cost.

A similar request was received from Dean Richard Sullivan, College of Arts and Letters, and Dean Keith Goldhammer, College of Education, to discontinue the Humanities Teaching Institute.

The Humanities Teaching Institute was also established in 1964 for the purpose of assisting in the improvement of teacher training programs in the humanities. The Institute has done a very effective job over the years, but the need for an identifiable institute has diminished to the point where its continuation at this time constitutes an unnecessary administrative cost.

RESOLVED that the Social Science Teaching Institute and the Humanities Teaching Institute be discontinued effective September 1, 1976.

Unanimously approved. Motion by Trustee Carrigan, seconded by Trustee Stevens.

6. In keeping with previously established policies and procedures, the College of Education (Therapeutic Recreation Program) has requested approval of an affiliation agreement between the University and the St. Lawrence Hospital for the development of teaching programs in therapeutic recreation.

The agreement is essentially the same as prior agreements with other hospitals executed by the Colleges of Human and Osteopathic Medicine. It has been examined by the Office of the Dean, College of Education, by the Office of the Provost, and by the University Attorney. The agreement comes to the Board of Trustees with the Administration's recommendation that it be approved.

RESOLVED that the affiliation agreement between Michigan State University, College of Education (Therapeutic Recreation Program), and the St. Lawrence Hospital Community Mental Health Center be approved.

Approved by a vote of 7 to 1 on motion by Trustee Bruff, seconded by Trustee Huff. Trustee Stack voted No.

7. a. Trustee Huff, on behalf of the Trustee Audit Committee, recommended that Ernst & Ernst's full report of the audit of the University's 1975-76 fiscal records and Vice President Wilkinson's response be approved.

Approval was moved by Trustee Huff, seconded by Trustee Martin, and unanimously voted.

- b. Trustee Huff reported that Ernst & Ernst had estimated the cost of the audit would be between \$70,000 and \$75,000. Their bill was \$73,546.19. This is a budget item and no Board action is required.
- c. It was the recommendation of the Trustee Audit Committee that Ernst & Ernst be employed to audit the 1976-77 records.

Motion was made by Trustee Bruff, seconded by Trustee Stevens to approve this recommendation. Unanimously carried.

d. Trustee Huff also reported that the Trustees have received confidential preliminary Auditor General's copies of the first report of the Auditor General on the audit of the Cooperative Extension Service and the Agricultural Experiment Station. Mr. Huff asked if the Trustees wished the Audit Committee to review the findings of the Auditor General with Vice President Wilkinson and appropriate people in Administration and prepare by October 30 the University's response to that report.

On motion by Trustee Bruff, seconded by Trustee Krolikowski, it was unanimously voted to request the Audit Committee to assume this responsibility.

- 8. Executive Vice President Breslin provided the following information regarding the Administration's intent to file applications under the Local Public Works Capital Development and Investment Act of 1976.
 - The intent of the Act is the employment of construction workers in areas of high unemployment through the renovation of useful public facilities.
 - b. The money is to be allocated by states. Michigan's current allocation is approximately \$157M. Grants will be made on a point system, most of which relates to the unemployment rate in the project area.
 - c. The original intent was that the State Department of Management and Budget would file for all state colleges and universities, but it now appears that it will be advantageous for the University to file its own applications.

- 8. Public Works Application List and Architects Selection for Public Works Program Application, cont.
 - d. Time is the key to the whole program. The grant application contains assurances that if an application is approved there will be workers on the site in 90 days. It is felt this can be done with the projects selected, but it will require other than our normal design and contracting procedures. It will undoubtedly be necessary to use phased construction and multiple contracts.
 - e. It is the intent of the Administration to file applications for the following projects:

President Wharton reported that (a) the above items were selected from the already existing capital outlay list, (b) their selection does not change the capital outlay priority in terms of the capital outlay request, (c) competition for funds will be extremely heavy since the \$157M will be allotted not only to state universities, but also to towns and villages.

Executive Vice President Breslin added that it will be necessary to appoint architects for two of the projects: the Engineering addition and the Upper Peninsula Experiment Station at Chatham. The present plan is to engage these consultants to assist in the preparation of the Federal grant applications only, but if the projects are funded either by Federal funds or other sources they would be continued on the projects. Albert Kahn Associates, Detroit, was recommended for the Engineering addition, and G. Arntzen of Escanaba was recommended as the architect for the U.P. Experiment Station.

On motion by Trustee Bruff, seconded by Trustee Huff, it was unanimously voted to approve the list of project applications and the recommended architects.

9. The following resolution was offered by Trustees Stack and Stevens:

WHEREAS, the people of Michigan will vote November 2 on a proposed amendment to the Constitution of the State of Michigan to limit all state taxes and expenditures to 8.3% of the combined personal income of Michigan; and

WHEREAS, approval of such an amendment would seriously limit the ability of the Governor and the Legislature to provide for the legitimate needs of the people of Michigan; and

WHEREAS, this additional limitation would further compound the problems of an existing fiscal system which has demonstrated its inability to maintain the state's bond ratings and has necessitated repeated midyear cutbacks in budgets for essential governmental services for all citizens of Michigan; and

WHEREAS, the Board of Trustees of Michigan State University is particularly concerned that the adoption of such a proposal would severely reduce the ability of the state to provide adequate appropriations for higher education thereby accelerating increases in tuition and fees for students and their families;

NOW THEREFORE, BE IT RESOLVED that the Board of Trustees of Michigan State University urges the voters of the state to vote "no" on Proposal C on November 2.

10. The following resolution was presented by Trustees Stevens and Stack:

WHEREAS, the Michigan State University community has long been aware of the humanistic philosophy and legislative talents of the state's senior member of the United States Senate, Philip A. Hart; and

WHEREAS, Michigan State University has formally recognized the outstanding service to the state and nation performed over the past 18 years by Senator Philip A. Hart with the awarding of an honorary degree in 1964, and most recently, the bestowing upon him of the Board of Trustees Distinguished Citizen Award in May 1976; and

WHEREAS, we note with pride the national acclaim that Senator Philip A. Hart Hart has received upon his announcement of retirement from the United States Senate, including the unique honor of having his colleagues name a new Senate office building for him in his lifetime; and

WHEREAS, it is important to the citizens and particularly the youth of the state of Michigan that Senator Philip A. Hart be remembered as exemplifying the finest qualities sought in a public servant;

NOW THEREFORE, BE IT RESOLVED that the Board of Trustees of Michigan State University restates its admiration of Senator Philip A. Hart and expresses its gratitude for his support of progressive legislation, including civil rights, education, consumer protection and the environment; and be it

FURTHER RESOLVED that the Board of Trustees joins with those in the State Legislature and elsewhere who would further honor Senator Philip A. Hart with a special day of appreciation.

President Wharton indicated he felt the present semi-autonomous relationship is ambiguous but if the Trustees decide to authorize the formation of an independent corporation, both the Trustees and the University officers should be represented on its Board. President Wharton said he felt that such representation was essential to assure full coordination of Alumni Association activities with the best interests of the University. He indicated his personal preference would be for greater integration of Alumni Association and University activities within the present organizational format, but that organization of the Alumni Association as an independent entity would be an acceptable second choice, assuming adequate representation of the Board and the University officers on the Alumni Association Board of Directors.

Mr. Kinney expressed his personal belief that the Executive Board of the Alumni Association would feel the University was exercising undue influence on Association affairs if there was substantial Trustee and University administrative representation on an independent Board. He noted that some other independently incorporated associations have only nominal membership from the Trustees or officers of their respective universities.

Further discussion of the substantive issue of how an independently organized association would bring greater benefits to the University or to the alumni than the present organizational relationship was inconclusive.
